ORDER

Whereas, the institution Mothers International Teachers Training Academy, Plot No. 963, Vill-Khalilpura, Po-Phulwarisharif, Tehsil/Taluka-Danapur, Town/City-Patna, Dist-Patna, Bihar-801505 was granted recognition vide ERC, NCTE order No.19968 dtd.05.08.2013 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2014-2015.

2. AND WHEREAS on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.09.01.2015 for its willingness of two basic units in B.Ed. course and adherence of provisions of new Regulations.

3. **AND WHEREAS**, provisional revised recognition order was issued to the institution on for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-2016.

4. **AND WHEREAS**, the compliance dt.26.10.2015 & dt.05.02.2018 was submitted by the institution received in this office on 09.11.2015 & 12.02.2018 respectively, considered by the ERC in its 261st Meeting held on 24th-25th September, 2018 and as decided to issue the show cause notice u/s 17(1) on 09.10.2018 to the institution.

5. AND WHEREAS, the ERC in its 278^{in} Meeting held on $16^{\text{th}} - 18^{\text{th}}$ January, 2020 considered the matter along with the reply received on 16.10.2018 submitted by the by the institution in response to SCN dtd.09.10.2018 and decided to issue the Final Show Cause Notice u/s 17(1) dtd.28.01.2020 on the following grounds:-

- i. Original list of teaching faculty duly approved by the affiliating body to be submitted.
- ii. Building Completion Certificate (BCC) duly signed by the competent authority to be submitted.
- iii. Original FDRs of Rs.5 lakh and Rs. 7 lakh to be submitted.
- iv. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.

6. AND WHEREAS, the institution has submitted the reply dt.08.02.2020 & dt.13.02.2020 received on 15.02.2020 & 17.02.2020, which has placed before the ERC in its 283rd Meeting held on 24th & 25th August, 2020and decided as under :-

- i. Original list of teaching faculty duly approved by the concerned affiliating body has not been submitted.
- ii. Building Completion Certificate (BCC) has not been duly signed by the competent authority.
- iii. Original FDRs of Rs.5 lakh and Rs.7 lakh has not been submitted.
- iv. Requisite information of the institutional website has not updated as per clause 7(14)(i) of NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

7. AND WHEREAS, The ERC in its 284^{th} Meeting held on $17^{\text{th}} - 18^{\text{th}}$ September, 2020, review the decision of ERC taken in 283^{rd} ERC meeting has been examined and Committee decided as under:-

Decision of 283rd meeting for withdrawal of the recognition stand cancelled. Accordingly, continuation of Revised Recognition Order (RRO) be issued.

8. Now Therefore, the ERC decided to permit the institution i.e. Mothers International Teachers Training Academy, Plot No.963, Vill-Khalilpura, Po-Phulwarisharif, Tehsil/Taluka – Danapur, Town/City-Patna, Dist-Patna, Bihar-801505 (ERCAPP1151) for continuation of recognition for B.Ed. course of two-years duration with an intake of 100 students (Two basic units) subject to fulfilment of the following conditions:-

- a) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- c) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- d) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- e) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a) Sanctioned programme(s) along with annual intake in the institution.
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left of joined during the last, quarter:
- d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e) Free charged from students.
- f) Available infrastructural facilities.
- g) Facilities added during the last quarter;
- h) Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its officials website.

12. The institution shall make available the list of students admitted on its officials website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.

14. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Eastern Regional Committee under the provisional of Section 17(21) of the NCTE Act, 1993.
