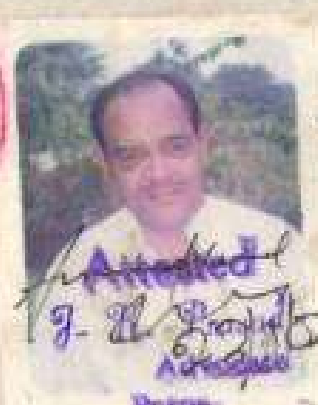

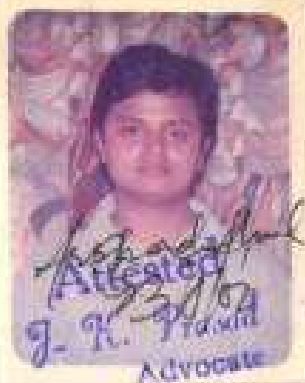

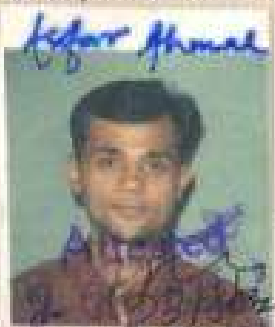

3.28. To do all such other lawful acts deeds or other things either above or in conjunction with other organisation as are incidental or conductive to the attainment of any of the above objects.

3.29. To provide for the welfare of staff of the Trust.

3.30. To make Rules & Regulations for the conduct of the affairs of the Trust and to amend, vary or revise them from time to time.

To accept upon such terms as the Board of Trustee may think fit any foreign grant, foreign donation or foreign contribution, as per the terms & condition laid down by the Government of India in this regard as well as in accordance with the terms, conditions & procedure laid down by the Home Ministry of India and other law applicable in this regard.

PROVIDED THAT the terms upon which such grants donations contributions shall be accepted shall not in any way be inconsistent with or repugnant to the objects of THESE PRESENT.

3.33. To accept gift, Atiya (amount given for charity by a particular community of world), Zakat (a certain percentage of wealth given for charity to assist financially weak persons by a particular community of world), Fitra (a fixed amount given by a particular community of world to assist weaker section of the society) and/or any other donation, by what so ever name called, by any person, to carry on the object referred hereto.

#### 4.05. VACANCY & ENGAGEMENT OF NEW TRUSTEES :

The president shall have power to remove any Board of Trustee and/or Trustees at any point of time without assigning any reason thereof.

If and when as the Trustees of These Presents die or desire to retire or refuse to or become incapable to act in the Trust or take the benefit of insolvency law for the time being in force or become of an illumined mind, lose nationality, disqualified by operation of law, or if any Trustees without leave remains absent from three consecutive meeting of the Board of Trustees or removed by the president or on account of any other reasons then in every such case it shall be lawful for the president to engage a new trustee on such terms & condition which may be stipulated by the President. Further more in case of any vacancy of Board of Trustee and/or Trustee which has been filled up by the President of the trust, the president shall have power to remove them from their post at any point of time without assigning any reason thereof.

**5.01. OPENING BANKING ACCOUNTS  
AND HOW TO BE OPERATED:**

The Trustees may from time to time open and maintain in the named of trust any banking account or accounts with such scheduled bank or banks or Central and provincial co-operative Bank or banks as may from time to time be determined by the Trustees and shall forthwith payes or cause to be paid the rents income profits dividends and all other money forming part of the Trust Fund to the credit of any such account or accounts. ### 5.04. TO PURCHASE HIRE OR TAKEN ON LEASE :

The Board of Trustees may from time to time at their discretion for the furtherance of the objects or the Trust or THESE PRESENTS aquired movable or immovable property from the fund of the Turst and if required/necessary to borrow money and for the purpose of this may authorised Trustees to borrow money at such rates of interest and in such forms and manner and there-upon the trustees shall at their discretion, make all such dispositions or the property movable or immovable forming part of the Trust Fund or

any part thereof and enter into such agreements, assurances and deeds in relation thereto as the Trustees may deem proper for giving to such loans & interest.

**5.09. GENERAL**

The Board of Trustees would be competent and empowered to do all such things as may be required for fulfillment of the objectives of the Trust as mentioned in clause.

**6.00. INVESTMENT :**

**6.01. INVESTMENT OF TRUST FUND :**

All moneys forming part of the Trust Fund and requiring investment shall be invested on behalf of and in the name of the Trust or the Trustees to be held exclusively for the purpose of the trust for the time being in or upon any or the Securities authorised by Income Tax Act 1961 or any other applicable law in force from time to time for investment of Trust Funds or in deposits with any scheduled bank or banks of Central, Provincial or district co-operative bank.

**6.02. IN WHOSE NAME, MONEY TO BE INVESTED :**

All moneys forming part of the Trust Fund and requiring investments shall be invested and the conveyance or other assurance in respect of any immovable

**7.0. FUNCTIONS AND DUTIES OF THE OFFICE BEARERS :**

**7.01. FUNCTIONS OF THE PRESIDENT :**

- (a) The President shall preside over the meeting of the Trust and other constituent units.
- (b) The President's duty shall be to ensure that these rules are enforced and resolutions of all the meeting are carried out.
- (c) The President shall call the meeting of the Trust through the Secretary as per rules.
- (d) He shall exercise general supervision over affairs of Trust and other organisations and may for this purpose issue instructions to those concerned.
- (e) To operate Bank account jointly with the Secretary or other members of the Board of Trustees.
- (f) He shall convey all meetings of the Trust on due dates and give intimations thereof to the members in time.
- (g) All contracts shall be entered into in his name on behalf of the Trust.
- (h) The President shall have power to constitute committee(s) for the purpose of facilitating the disposal of trust work. If the President think fit to constitute a sub-

## 7.02. FUNCTION AND DUTIES OF THE SECRETARY :

(a) The Secretary shall be the Executive officer of the Trust and shall conduct all official correspondence ~~under his signature~~ and he shall have supervisory power over all the Institution of the Trust and shall have powers of visiting the institution as and when necessary for discharging the duties.

(b) He shall prepare the agenda of a meeting under the direction of the President.

(c) It shall be his duty to see that proper accounts are kept and documents prepared as per rules of all the income and expenditure.

(d) He should get the accounts audited according to rules. He would deposit all the collections made in the ~~bank working day~~ as far as possible.

(e) The Secretary will the every meeting submit the report of the working of the Trust and its units along with a detailed statements of receipts and expenditure and cash and bank balance for the consideration by the Trust.

## 7.3. FUNCTION OF THE TREASURER:

(a) The Treasurer shall be responsible for

#### **8.0. ACCOUNTS AND YEARS :**

##### **8.01. ACCOUNTS AND AUDIT :**

The trustee shall get maintained regular accounts of the Trust Fund and shall get the same duly audited by a competent accountant. The accounts and audit report and the reports of the Trustee shall be furnished atleast once a year.

8.02. The accounts of the trust would be closed and balanced on 31st March each year.

#### **9.0. MEETING AGENDA QUORUM**

##### **9.01. MEETING :**

All meetings of the trust shall be called by the President.

9.02. Decisions at a meeting of the Trust shall be by a majority of votes.

9.03. At least 7 days previous notice of meeting shall be given to members for ordinary meeting and day's notice for emergency meeting provided that in case of urgency if the President so thinks fit a Resolution also passed by circulation. This time period may be extended or reduced by the president if the president think fit to do so.

9.04. In case the votes are equal, the President shall have casting vote.

9.05. President and one of the Board of

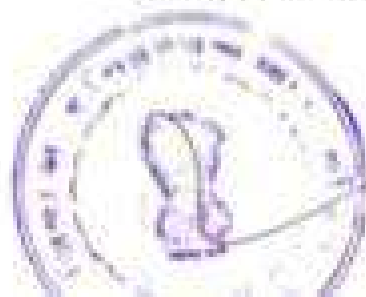



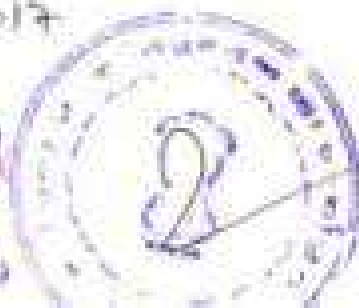
